Backup Jobs can take considerable time depending on the internet link where the data travels, APS will only provide accompaniment for a maximum period of up to 8 hours, if accompaniment is required during the rest of the initial backup process, the required hours may be billed additionally. Recovery testing can take considerable time depending on the internet link where the data travels, APS will only provide support for a maximum of 4 hours, if accompaniment is required during the rest of the initial support process the additionally hours may be billed. No Infrastructure, Network or Security (Local Premises or Cloud) configuration tasks required for proper operation of the Veeam Backup for Office 365 server will be performed. No backup configuration of existing Active Directory Servers, Microsoft Exchange Server or Microsoft SharePoint Server on Customer premises will be performed. No backup of items, Personal or Corporate Repositories stored in OneDrive for Business will be performed. No backup of items, Personal or Corporate Repositories stored in SharePoint Online will be performed. Additional configurations that may be required in Office 365 for integration with Veeam are the responsibility of the customer. Opening Office365 Support cases is the responsibility of the customer. Backup activities of backing up Objects or Identities from other Office 365 organizations are not covered, nor is backup of Objects or Identities from other Active Directory domains or forests, Office 365, Microsoft Exchange Server, Microsoft SharePoint Server, etc. No backup of Hybrid Organizations or configuration of multi-factor authentication will be performed.
